4) The Farnborough and District u3a **newsletter** is produced 3 times a year. It is usually sent to members by email.

A. Bank Transfer (Preferred method please). Email your completed form to membership@u3afarnborough.org.uk The Membership Secretary will then email the bank details to enable you to pay by bank transfer.

B. Cheque. Print this form and post it with a cheque payable to Farnborough & District u3a to Judith Layzell, 32 Osborne Road, Farnborough GU14 6AF. Your membership card will be returned to you by email, for you to print out or save to your phone. If you require a printed membership card, please enclose a stamped addressed envelope with your application.
